Thank you for making the effort to respond to our request for your Chapter's report. The life and health of our Order is dependent upon such dedication and commitment. Something you may not know about the Nebraska Order of the Eastern Star. Nebraska Grand Chapter has funds to loan for vocational, undergraduate, or post graduate education.

graduate education.

To qualify for a loan you must be a member of the Order of the Eastern Star of the State of Nebraska, or be related to a current or former member, in good standing, of a Eastern Star Chapter of the State of Nebraska.

A student may borrow up to \$2,200.00 per semester for vocational, undergraduate, or post graduate education. The total amount that can be borrowed is \$17,000.00. Applicants must be 18 years of age or a high school graduate. The applicant is

required to sign a note for the loan and obtain a co-signer.

Even though principal is not due for four years from the date the note is taken, interest is due when billed. Interest is charged at 4% per year.

All Nebraska Eastern Star members and their qualified relatives are encouraged to consider an Educational Loan from Nebraska Order of the Eastern Star.

Applications are available online at www.neoes.org or call Nebraska Grand Chapter Office at 402.937-7056. The complete application must be mailed to the Grand Chapter office no later than April 1st of each year.
